Notes for many data fields have been clarified to make mandatory conditions and values clear.

WIBRS Program Overview

As mandated by the Wisconsin Legislature [Wisconsin Statute 165.845], the Wisconsin Department of Justice, through the Bureau of Justice Information and Analysis, is responsible for collecting information concerning the number and nature of criminal offenses known to have been committed in the state. This includes collecting crime and arrest data from more than 400 law enforcement agencies for the FBI's Uniform Crime Reporting (UCR) Program, which was initiated in 1930. The primary objective of UCR is to generate reliable information for use in law enforcement administration, operation, and management. In 1998, the FBI released data elements and offense specifications of a new system known as the National Incident-Based Reporting System (NIBRS). The Wisconsin Incident-Based Reporting System (WIBRS) is a state-specific version of NIBRS that has been operational since 2005.

WIBRS Submission Requirements and Guidelines

- One WIBRS submission file must be submitted each month by certified WIBRS reporting agencies.
- The submission file must be a text formatted file, with the file extension .txt.
- Each Group A incident must contain, at minimum, the Administrative, Offense, Victim, and Offender segments.
 - Crimes Against Property offenses and Kidnapping will additionally require a Property segment – see pages 6-8 of this manual for the complete list of these offense codes.
- Resubmissions of the most recently processed month are allowed.
 - A resubmitted file will completely cancel and reverse the file previously submitted for that month.
 - Therefore, resubmitted files must include all incidents from the original file for that month in addition to any corrections or updates.

Zero Reports

Zero reports are used to indicate that nothing reportable (neither offense nor arrest/citation) occurred during the entire reporting month. A zero report is submitted in WIBRS as one line of code in a text submission file, and it must be the only line of text in the file to process correctly. In other words, do not submit both a zero report and other incident data in the same submission file. If an agency later submits a file to replace a previously submitted zero report, the zero report would be canceled from the state's database and replaced with the incident data.

Unfounded Incidents

The unfounded designation should be used if a Group A incident is determined to be baseless or false. In other words, an incident should be unfounded if the investigation shows that no offense occurred or was attempted. The unfounded designation must apply to all offenses on the incident. Incidents that have been marked as unfounded will not be included in data reports created in Wisconsin, nor will unfounded incidents be sent by the state to the FBI. If an incident previously sent to the FBI is later marked by the agency as unfounded, a Delete record will be sent by the state to the FBI for that incident so that it will be removed from the FBI's database.

Deleting an Entire Incident

In the rare cases where a complete removal of an incident is appropriate, you may find it easiest to mark the incident as unfounded, however a Delete record will be processed. If the incident is marked as unfounded, it will remain in the state's data, but will not be used for reporting or sent to the FBI (see "Unfounded Incidents").

Updating Group A Incidents

If a change has been made to a previously reported Group A incident, the entire incident should be resubmitted. Examples of changes include: adding an exceptional clearance, reporting demographic characteristics of a suspect/offender previously reported as unknown, or adding an arrest. The resubmitted incident should be sent with a Delete of the administrative segment, followed by Inserts of all applicable segments. All Group A incidents submitted during the previous year or year-to-date in the current year of the submitted file can be updated. Group A incidents that were submitted prior to the previous year can only be updated if the agency is adding an exceptional clearance, adding recovered property, or adding an arrest. In those instances, the date of the exceptional clearance, recovered property, or arrest must be within the previous year or year-to-date in the current year of the submitted file (see Submission Window below).

Deleting Group B Arrests

WIBRS requires the arrestee transaction number and arrestee sequence number to be included with all Group B Arrest Segment deletion instructions. The state will then remove the Group B arrest for the specific arrestee(s) rather than automatically removing all arrestees from the Group B incident.

Submission Window

The submission window refers to January through December of the previous year as well as the year to date in the current year of the submitted file. For example, in June of 2019 the submission window includes January – December 2018 plus January – June 2019. Therefore, the width of the submission window can span between 13 months (in January) and 24 months (in December). Note that this enforcement is based on the month and year of the submitted file. For example, a December 2017 file submitted in January will still be processed by WIBRS.

Any change can be made to incidents that occurred within the submission window. However, previously reported Group A incidents that occurred prior to the submission window can only be changed in three ways:

- Add an exceptional clearance
- Add recovered property
- Add an arrest

Any adjustment to an incident submitted outside of the submission window must have an exceptional clearance date, property recovery date, or arrest date within the current submission window. The resubmitted incident should be sent with a Delete of the administrative segment, followed by Inserts of all applicable segments.

List of Major Programmatic Changes - Effective January 2019

Time Window Change

The time window previously referred to the WIBRS action types for special, abbreviated record adjustments to incidents occurring prior to the previous year. Time window segments are no longer accepted. Record positions for all time window-specific data elements are now reserved for future use.

The previous time window additions, or modifications to previously submitted time window incidents, were submitted by using the following segment action types:

- W – Time Window: adds a new time window record (property, arrest, or exceptional clearance) **(Deprecated in 2019)**
- M – Modify: modifies a previously submitted W record **(Deprecated in 2019)**

Domestic/Family Violence

In December 2016, the CJIS Advisory Policy Board (APB) approved the definition of domestic and family violence as:

“The use, attempted use, or threatened use of physical force or a weapon; or the use of coercion or intimidation; or committing a crime against property by a current or former spouse, parent, or guardian of the victim; a person with whom the victim shares a child in common; a person who is or has been in a social relationship of a romantic or intimate nature with the victim; a person who is cohabiting with or has cohabited with the victim as a spouse, parent, or guardian; or by a person who is or has been similarly situated to a spouse, parent, or guardian of the victim.”

- As a result, in Data Elements 22 and 23 (Aggravated Assault/Homicide Circumstance), data value 06 = Lovers’ Quarrel will change to 06 = Domestic Violence.
- In addition, Data Elements 31, 33, 35, 37, 39, 41, 43, 45, 47, and 49 (Relationship of Victim to Offender) will be accepted for Crimes Against Property offenses.

Negligent Manslaughter Change

The definition of Negligent Manslaughter is “The killing of another person through negligence.”

The *2019.1 National Incident-Based Reporting System User Manual* also states, “This offense includes killings resulting from hunting accidents, gun cleaning, children playing with guns, and arrests associated with driving under the influence, distracted driving (using cell/smartphone), and reckless driving traffic fatalities. **Note:** It does not include deaths of persons due to their own negligence, accidental deaths not resulting from gross negligence, or accidental traffic fatalities.”

- As a result, in Data Elements 7, 8, and 9 (Offender(s) Suspected of Using), value C= Computer Equipment will be modified to C= Computer Equipment (Handheld Devices)
- In addition, in Data Elements 16, 18, and 20 (Type of Weapon/Force Involved), value 35= Motor Vehicle will be modified to 35= Motor Vehicle/Vessel

Cargo Theft Change

Cargo Theft added to the WIBRS in January 2019.

- Valid data values for Data Element 22 are Y=Yes, N=No
- (blank) = Not a Cargo Theft Offense
- Data Element 22 now = Cargo Theft and Data Element 23= For Future Use. Cargo theft-related offenses include:
 - 120 = Robbery
 - 210 = Extortion/Blackmail
 - 220 = Burglary/Breaking and Entering
 - 23D = Theft From Building
 - 23F = Theft From Motor Vehicle
 - 23H = All Other Larceny
 - 240 = Motor Vehicle Theft
 - 26A = False Pretenses/Swindle/Confidence Game
 - 26B = Credit Card/Automated Teller Machine Fraud
 - 26C = Impersonation
 - 26E = Wire Fraud
 - 26F = Identity Theft
 - 26G = Hacking/Computer Invasion
 - 510 = Bribery
 - 270 = Embezzlement

Property Description Change

The property description 99 = Blank (not currently used by the FBI) was removed by the FBI in 2019. This data value is longer accepted.

Relationship of Victim to Offender Change

The relationship of victim to offender data value HR = Homosexual Relationship was removed by the FBI in 2019. SE = Victim was Spouse, BG = Victim was Boyfriend/Girlfriend, XR = Ex-Boyfriend/Girlfriend, or XS = Victim was Ex-Spouse should be used in place of HR.

Appendix III: WIBRS Technical Specification Changes Published Prior to 2019

List of Major Programmatic Changes - Effective January 2016

General Changes

- All data elements are designated as either **Required** (must be included in all submissions), **Conditional** (included if other conditions are met, such as with particular offense codes), or **Optional** (only included if applicable). The Required designation is a change from the previous terminology of Mandatory.
- Terminology has been updated throughout the technical specifications document to match the terminology used by the FBI's national IBR program (NIBRS). These updates apply to the names of data elements as well as data values. Descriptions have also been updated to increase clarity.

Offense and Arrest Codes

- New UCR Offense Code values
 - **720 = Animal Cruelty:** Defined as "Intentionally, knowingly, or recklessly taking an action that mistreats or kills any animal without just cause, such as torturing, tormenting, mutilating, maiming, poisoning, or abandonment. Included are instances of duty to provide care, e.g., shelter, food, water, care if sick or injured; transporting or confining an animal in a manner likely to cause injury or death; causing an animal to fight with another; inflicting excessive or repeated unnecessary pain or suffering, e.g., uses objects to beat or torture an animal." This definition does not include proper maintenance of animals for show or sport; use of animals for food, lawful hunting, fishing, or trapping. Animal cruelty is a crime against society.
 - **26F = Identity Theft:** Defined as "Wrongfully obtaining and using another person's personal data (e.g., name, date of birth, Social Security number, driver's license number, credit card number)." Identity theft is a crime against property (Fraud).
 - **26G = Hacking/Computer Invasion:** Defined as "Wrongfully gaining access to another person's or institution's computer software, hardware, or networks without authorized permissions or security clearances." Hacking/computer invasion is a crime against property (Fraud).
- Retired UCR Arrest Offense Code value
 - **90I = Runaway** will no longer be collected.

Criminal Activity/Gang Information

- Four criminal activity types were added that are specific to and only to be used with the new **Animal Cruelty offense (720)**:
 - **A = Simple/Gross Neglect** (unintentionally, intentionally, or knowingly failing to provide food, water, shelter, veterinary care, hoarding, etc.)
 - **F = Organized Abuse** (dog fighting and cock fighting)
 - **I = Intentional Abuse and Torture** (tormenting, mutilating, maiming, poisoning, or abandonment)
 - The I code was previously used in WIBRS to indicate possession with the intent to deliver. A code of I will now err unless it is accompanied by offense 720. Historical use of the I code regarding drug possession will be maintained in the state's data repository.
 - **S = Animal Sexual Abuse** (bestiality)

- The S code was previously used in WIBRS to indicate suspicion/conspiracy. A code of S (which was discontinued in 2013) will now err unless it is accompanied by offense 720. Historical use of the S code relative to suspicion will be maintained in the state's data repository.

Bias Motivation

- New category of "Race/Ethnicity/Ancestry" which includes the biases against race, ethnicity, and origin.
- New Bias Motivation values
 - Race/ethnicity/ancestry bias:
 - **31 = Anti-Arab**
 - Religion biases:
 - **28 = Anti-Mormon**
 - **29 = Anti-Jehovah's Witness**
 - **81 = Anti-Eastern Orthodox (Russian, Greek, Other)**
 - **82 = Anti-Other Christian**
 - **83 = Anti-Buddhist**
 - **84 = Anti-Hindu**
 - **85 = Anti-Sikh**

Other Added Codes

- New Location Type value
 - **14 = Hotel/Motel/Etc.:** Includes other temporary lodgings
 - **20 = Residence/ Home:** Includes apartments, condominiums, townhouses, nursing homes, residential driveways, residential yards, and extended/continuous care facilities.
 - **58 = Cyberspace:** A virtual or Internet-based network of two or more computers in separate locations, which communicate either through wireless or wire connections.

Segment Processing Rules

- **Segment Action Type M** can now only be used to modify a previously-submitted time window record.
- **Segment Action Type A** should no longer be reported for the Group A Arrestee Segment. Instead, either delete and insert the entire incident, or submit the arrest by itself as a time window record (W) if the arrest occurred prior to the current time window or prior to the IBR base date.

Retiring Wisconsin-Specific Codes and Values

- To better match the National Incident-Based Reporting System, many of the codes used only in Wisconsin are being retired in 2016. These codes will continue to be accepted through 2016, but will error after the transition period; erring is anticipated to begin in early 2017.
- These codes have been removed or altered:
 - Offense segment
 - **UCR Offense 11E:** Ejaculate/Excrete on Victim. These offenses should now be coded as 13B, Simple Assault.
 - **Attempted/Completed code O:** Ongoing. Use only A (attempted) or C (completed).
 - **Location types 91, 92, and 93.** These locations should now be coded as 25 (Other/Unknown) unless another description is a better fit (such as 13, 18, or 23).
 - **Location types 94, 95, and 96.** These locations should now be coded as 14 (Hotel/Motel/Etc.).
 - **Location types 97, 98, and 99.** These locations should now be coded as 20 (Residence/Home).
